Cost of Advisory Services

An initial meeting to discuss your financial circumstances is free of charge. At this meeting Chris will establish how he can assist you and gather the information required to prepare a financial plan.

Chris will discuss the fee basis with you and agree on the method of charging prior to any advice is provided or cost incurred. Also, fees are fully disclosed in the Statement of Advice and Product Disclosure Statements.

Payment can be collected through a platform, by direct debit or invoiced. A fee for the preparation of the Statement of Advice will be charged even if the recommendations are not implemented. For insurance, the commission may be paid by the insurance provider. Further advice that includes portfolio reviews may be charged on a percentage fee basis which varies according to the portfolio amount, or as a fixed dollar amount depending on the complexity and structure, as agreed with your adviser.

All fees include 10% GST.

All fees are payable to Prime Time Advisory. Prime Time Advisory retains 100% and pays Chris Pantu a salary and as a director/shareholder of Prime Time Advisory is entitled to a Director's drawing and/or dividend if and when paid.

This commission has what is called a 'responsibility period' imposed by the risk product issuer. This means that if the policy is cancelled within the first 1-2 years of inception commission is returned to the product issuer by Prime Time Advisory.
